DAYCARE IN HOME

When you operate a daycare in your home, you are entitled to claim part of your household expenses as deductions on your Statement of Business Income when you prepare your income tax return. Daycare services are tax exempt therefore there is no requirement for an HST number.

- MORTGAGE INSURANCE
- MORTGAGE INTEREST
- WATER TAXES (IF ANY)
- INSURANCE

- Furniture
- Toys
- Household Food (keep 100% of all your bills for entire household)
- Snacks (dedicated to daycare)
- Office Supplies

Tax Time

Provide me with the full amounts you paid for each category. I will determine the percentage of your deductions depending on how many children you are caring for and the square footage of your home.

Provide all the sheets - Annual Information Sheet + 12 monthly sheets to me at year end please do not give me the receipts but KEEP THEM for 7 years in case Revenue Canada ever asks to see them).

Make sure that **ALL SECTIONS** of the Annual Information Sheet are duly completed. Providing me with incomplete sections may cause delays in preparing your tax return.

If you have purchased a single item that has a value of over \$500 (before taxes) for your daycare (ie play structure, swing set, etc.) DO NOT include this with your Expenses. Provide this receipt (and ONLY this receipt) to me. Items over \$500 must be depreciated over the course of 5 years and cannot be expensed at full cost during the year of purchase.

* Maintenance includes all cleaning supplies and services such as snow removal, lawn care, weed control, sewer draining, etc. It does NOT include renovations to your home.
